New Solid Waste Recycling and Transfer Station Schedule

On December 1st, 2009 Hawai'i County will be reducing the operating hours and days at County Solid Waste Recycling and Transfer Stations around the island (a.k.a. Solid Waste Transfer Stations).

The new schedule of hours (see chart below) was developed due to labor agreements, existing resources and a tightened budget. More County staff will be on hand to supervise the transfer stations. Businesses and non-residential organizations are still prohibited from using the transfer stations.
